VOTING IN NORTH DAKOTA

If you are a United States citizen, at least 18 years old, and live in North Dakota for 30 days prior to an election, you have the right to vote!

North Dakota does not require voter registration, but you do need to have a proper form of identification that can be used for voting.

HOW DO I VOTE?

Find information about voting options and resources for preparing to vote at vote.nd.gov.

- You can vote by **absentee**, or by **mail**.
- You can vote at an **early** voting location.
- You can vote on **Election Day**.

VOTER IDENTIFICATION

You need one of these forms of ID to vote:

- **North Dakota Driver's License**
- **North Dakota Non-Driver ID**
- **Tribal ID or Tribal Letter**
- **Long Term Care Certificate**

Identification, tribal government IDs, or documents should have your name, residential address, and date of birth.

CORRECTING ADDRESSES

If you have moved since your ID was issued, you will need to update it before Election Day. The North Dakota Department of Transportation allows you to **update your address** and make **appointments** online for new IDs.

WHAT IF MY ID ISN'T UPDATED BEFORE ELECTION DAY?

Having a valid form of identification with your current information can make your voting process easier. If you do not get your identification updated, or find you do not have your identification with you when voting, you have two options:

NON-UPDATED ID SUPPLEMENTAL DOCUMENTATION

You can bring your non-updated identification, along with supplemental information that includes your updated address, to the polling location on Election Day. Supplemental documentation that will be accepted includes a:

- Current bank statement or utility bill
- Paycheck or paystub
- Check or document issued by federal, state, tribal, or local government
- Printed document issued by a college or university + student ID

NON-UPDATED ID / DO NOT HAVE ID SET ASIDE BALLOT

You can vote by set-aside ballot during early vote or on Election Day. This means you cast your ballot and it is placed in an envelope to be presented to the County Canvassing Board for review.

- Within 13 days after the election, you must update or present your driver's license, non-driver ID, Tribal ID or documentation, or Long Term Care Certificate before the County Canvassing Board meets.
- You may submit your identification in person or electronically to the county auditor, and your ballot will be counted. You will be provided information about this process when voting a set-aside ballot.
